The following is a summary of the Executive Director's Report for the LTA meeting of October 24, 2018:

- 1. 2012 LTA Bond Projects: The following lists the remaining funds for the LTA 2012 Bond as of June 30, 2018.
  - a. The City of Calexico has turned in a requisition in the amount of \$537,694.82 and is being reviewed currently by ICLTA staff. The City of Calexico is also working on a 2018 Street Improvement Project. Construction began May 2018 and is expected to be completed late October 2018. The remaining bond proceeds will be used for this project.
  - b. The City of Brawley has stated that they are working on a Phase XI project that will conclude in September 2018. The remaining bond proceeds will be used for this project.

- 2. LTA Bond Series 2018A 2018B 2018C: The LTA Board took action on June 27, 2018 for the cities of Calipatria, Calexico and Holtville to pursue a new series of LTA bonding. The 2018ABC series totals \$16,765,000 which includes \$12,375,000 for Calexico, \$1,450,000 for Calipatria and \$2,940,000 for Holtville. The Purchase Contract was executed on September 13<sup>th</sup> and Official Statement was circulated for signature on September 20<sup>th</sup>. The Bond closed on September 26, 2018.
- 3. LTA Audit FY 2017-18: The three year LTA audit contract was awarded to the firm of The Pun Group. A project kick off meeting for member agencies was held at the ICTC offices on September 6<sup>th</sup>. The audit team is expected to schedule visits and interviews with agencies' finance staff for the week of November 26, 2018 November 30, 2018. The auditor's goal is to have a draft by late December. Please provide ICLTA with updated 5-year Expenditure Plans and Maintenance of Efforts Certificates (Calexico, El Centro and Imperial) if you haven't done so already.
- 4. City of Westmorland Member Agency Coordination and Documentation: At the July 25, 2018 Board meeting with the acceptance of the City of Westmorland FY 2016-17 LTA audit, it was requested that LTA staff assist the City in addressing the FY 2016-17 audit findings. LTA has met with City staff on August 3<sup>rd</sup> and September 5<sup>th</sup>, 2018 to review the findings and discuss preparation for the upcoming LTA audit FY 2017-18. The next meeting will be scheduled after a review and recommendation from the auditor, The Pun Group, is provided.
