Mr. Mercado stated that there was one finding and is listed as follows: We noted the following finding during our examination of the Local Transportation Authority Funds of the City of Westmorland.

### Finding:

During the examination, we noted that the City was not allocating interest revenue to the LTA Revenue Fund.

#### Recommendation:

The City should review their funds for interest earned and allocate corresponding interest to LTA Fund Revenue

Mr. Terrazas requested that a formal letter from the LTA Board be written and sent to the City of Westmorland, requesting that the City remedy the "finding" in both the LTA Financial Reports, FY 2010-11 and FY 2011-12. There was consensus with his request.
