#### Re: Local Transportation Authority (LTA) Funds Traffic Control Services for SR-98 and Cesar Chavez Boulevard

Dear Mr. Baza:

On behalf of the City of Calexico please accept this request \$75,000.00 under the Local Transportation Authority (LTA) to assist the City with traffic controller services on State Route 98 and Cesar Chavez Boulevard for Fiscal Year 2019-2020. This is a regional issue; the traffic issues are caused by long border wait times entering Mexico. The City of Calexico is incurring this cost due to the proximity to the border.

The traffic controllers are needed to address the existing and anticipated traffic congestion created within the City of Calexico by traffic crossing the International Border at Calexico West Land Port-of-Entry. The funds requested will allow us the opportunity to mitigate existing congestion.

The requested amount is half of the funding allocated for fiscal year 18-19. It is anticipated that the city will need about half of the traffic controllers due to the newly completed Cesar Chavez Project.
