SUBJECT: Public Hearing: Adoption of LTA Maintenance of Effort Resolution Amending the

Measure D Expenditure Plan

Dear Board Members:

The Measure D Local Taxpayer Supervising Committee met in March 2025 and directed LTA staff to revise the ordinance to update the Maintenance of Efforts (MOE) expectations and requirements. The proposed adjustments to the MOE requirements were also discussed during the adoption of the LTA Audit Documents.

The Section 6 Maintenance of Effort explains that the intent of the Legislature and Authority is that revenues provided by Measure D be used to supplement existing local revenues for the maintenance of street and roads. The original MOE was set up as a formula-based calculation on a three-year period average of the State Controller's Annual Report for Streets and Roads discretionary funds expended for participating agencies FY 2002-2003 through 2005-2006. This base value is then annually adjusted for inflation based on CPI.

To understand the inequity of the original MOE calculation; for FY 2023-24, the MOE for the City of Brawley was \$504k, the City of Calexico \$1.4 million, the City of Imperial \$40k, and the City of El Centro \$2k. The cities of Calipatria, Holtville, Westmorland and the County of Imperial MOE were zero. Several agencies have expressed concern over meeting the MOE requirement and have had audit findings issued to them because of not being able to meet the MOE requirements.

The intent of this amendment is to ensure that all agencies have a more comprehensive and equitable annual MOE. The new language will remove the formula and will ask the agencies to continue pursuing grants and other funds for the maintenance of streets and roads to support the Measure D funds.

Legal counsel assisted staff in a review of other Self Help counties' ordinances and determined that Section 6, sentences 2-4, of the LTA's Ordinance's Expenditure Plan can be deleted and replaced. Section 10 of the LTA's Ordinance's Expenditure Plan provided that the Expenditure Plan may be amended to further its purposes by ordinance or resolution, passed by a roll call vote entered in the minutes, with two-thirds of the Authority, or six board members concurring.

ICTC remains committed towards working with our local agencies to continue to deliver the purpose of the LTA. ICTC Staff forwards this item to the LTA Board for their review and approval after public comment, if any:

1. Authorize the chairman to sign the resolution of the LTA amending the Maintenance of Effort requirements by amending the Ordinance's Section 6 Expenditure Plan.

WHEREAS, the Imperial County Local Transportation Authority (hereinafter "LTA" or "Authority") was created by the Imperial County Board of Supervisors in 1989 with the concurrence of a majority of the cities having a majority of the population in the incorporated area of the County to administer a local option sales tax, namely, the Imperial County Local Transportation Authority Retail Transactions and Use Tax Ordinance and Expenditure Plan, commonly called Measure D (hereinafter "Ordinance" or "Measure"), attached hereto as Exhibit "A", as adopted by the electorate on November 7, 1989 and readopted on November 4, 2008; and

WHEREAS, LTA by-laws section 3 and Ordinance section 3 provide that LTA is governed by, and the Ordinance enacted pursuant to, the Local Transportation Authority and Improvement Act of 1987 codified at Division 19 (sections 180000-180264) of the Public Utilities Code; and

WHEREAS, the Ordinance's Expenditure Plan section 6 currently provides that Maintenance of Effort ("MOE") amount is determined by the FY 05-06 State Controller's Annual Report of Financial Transactions as follows:

"Each Local Agency receiving revenues pursuant to Section 4 shall annually maintain as a minimum the same level of local discretionary funds expended for street and road purposes as was reported in the State Controller's Annual Report of Financial Transactions for Streets and Roads - Fiscal Year 2005-2006. If any Local Agency had extraordinary local discretionary fund expenditures during FY 2005-2006, it may use, as a base for determining the minimum level of local discretionary funds, the average amount of such funds reported to the State Controller for the three-year period FY 2002-2003 through 2005-2006. The use of a three-year average for the base period shall be subject to Authority approval."

; and

WHEREAS, in order to ensure that all agencies have more comprehensive and equitable annual MOE, the Ordinance's Expenditure Plan should be amended; and

WHEREAS, the Ordinance's Expenditure Plan section 10 provides that the Expenditure Plan may be amended to further its purposes by ordinance or resolution, passed by roll call vote entered in the minutes, with two-thirds of the Authority concurring; and

WHEREAS, Public Utilities Code section 180207 provides that the Authority shall notify the board of supervisors and the city council of each city in the county and provide them with a

copy of the proposed amendments, and the proposed amendments shall become effective 45 days after notice is given; and

WHEREAS, LTA desires to amend Ordinance's Expenditure Plan section 6 to be more comprehensive and equitable.

WHEREFORE, THE IMPERIAL COUNTY LOCAL TRANSPORTATION AUTHORITY RESOLVES AS FOLLOWS:

1. Section 6, sentences 2-4, of the Ordinance's Expenditure Plan are deleted and replaced by the following:

"Each Local Agency receiving revenues pursuant to Section 4 shall continue to seek maximum funding for transportation improvements through State and federal programs while annually maintaining their existing commitment of transportation funds for purposes pursuant to this Ordinance and the Authority shall enforce this provision by appropriate actions, including fiscal audits. The Authority will not provide transactions and use tax revenue to any city or to the County unless all transportation revenues currently used by that jurisdiction continue to be used for transportation purposes.

- 2. Except as provided herein, the terms of the Ordinance and Expenditure Plan are confirmed in all respects and shall continue in full force and effect.
- 3. Subsequent to the passage of this Resolution, LTA staff shall send notification to the Board of Supervisors and the city council of each city in the county and provide them with a copy of the amendments, which shall become effective 45 days after notice is given.

The proposed changes on Section 6, sentences 2-4 of the Ordinance's Expenditure Plan are deleted and replaced by the following:

"Continue to seek maximum funding for transportation improvements through State and federal programs while annually maintaining their existing commitment of transportation funds for purposes pursuant to this Ordinance and the Authority shall enforce this provision by appropriate actions, including fiscal audits. The Authority will not provide transactions and use tax revenue to any city or to the County unless all transportation revenues currently used by that jurisdiction continue to be used for transportation purposes."


